GENERAL DATA PROTECTION REGULATION

INFORMATION RELATING TO THE PROCESSING OF PERSONAL DATA

Arras Pays d'Artois local public company Tourist Office collects and processes your personal data directly from you, in its capacity as data controller, for the purposes of managing your registration for the French Fries World Championships, taking your participation into account, determining the winners and managing the prizes. The legal basis for the processing is the performance of a contract. Candidates who fail to provide this information will not be able to take part in the Championships.

The data collected will be communicated only to the following recipients:

- Institutional partners (for example, the Hauts-de-France Region)
- Private partners (sponsors of the French Fries World Championships)
- Media (TV, press, etc.)

Certain data may nevertheless be kept for 5 years beyond the end of the Championships for evidential purposes, in the event of a dispute or claim on your part.

Under no circumstances will your personal data be used for commercial prospecting purposes.

In accordance with data protection regulations, you have the right to access your personal data, rectify it, delete it, oppose it or exercise your right to limit the processing of your data. You may also exercise your right to data portability and the right to formulate post-mortem directives. You will receive a reply within one month of receipt of your request. However, this deadline may be extended to two months if the request is complex and/or if there are too many requests.

Persons who exercise their right to have their personal data deleted before the end of the Championships will be deemed to have waived their right to take part.

The processing of your data does not involve the transfer of data outside the European Union within the meaning of the applicable regulations.
